### WELCOME OF KELLOGG COMMUNITY COLLEGE SIXTH PRESIDENT

Chair Steve Claywell and Board of Trustee's welcomed Dr. Adrien L. Bennings as Kellogg Community College sixth President since the institution's founding in 1956.

#### PRESIDENT'S REPORT

**Employee Recognition:** President Bennings recognized Kellogg Community College employees who recently received service pins for their years of service to the college. Forty-five Service Pins were distributed during Interim Session 2020, and Sharon Powell was applauded for her 40 years of service.

**Enrollment Update:** Dr. Kay Keck, Vice President, Student and Community Services reported that as of January 14, enrollment for the upcoming semester is above the same period a year ago by .94 percent in contact hours, .21 percent in credit hours and .57 in head count.

Higher Learning Commission (HLC) Multi-Location Site Visit Result: Dr. Paul Watson, Vice President, Instruction, reported the College received the highest commendation possible for the November 4, 2019 visit to the Grahl Center and the College's operations at the Branch Area Career Center (BACC). Dr. Watson extended his gratitude to all faculty, staff and students at both locations as well as Kris Jenkins, Superintendent, Branch Intermediate School District and Shari Deevers, Director, Grahl Center.

**Higher Learning Commission (HLC) Reaffirmation of Accreditation:** Dr. Paul Watson, Vice President, Instruction, reported the HLC Steering Committee remains on schedule and making continuous progress toward completing the College's assurance argument in time for the scheduled HLC Accreditation site visit scheduled for October 2021. An initial draft of the argument is expected to be available for campus review in August 2020.

**KCC Foundation:** Teresa Durham, Executive Director, KCC Foundation reported on year-to-date donations received and provided an update on new funds and grants, scholarship application dates and on the recently organized Bid a Brighter Future event.

**Scholarships and Grants:** President Bennings reported the College received \$17,583.57 in scholarships and grants over the past month, with a fiscal year-to-date total of \$309,665.54.

President Bennings provided a brief update of coming events.
