Kellogg Community College Minutes of the Regular Meeting of the Board of Trustees May 19, 2021

The regular meeting of the Kellogg Community College Board of Trustees was held on Wednesday, May 19, 2021, via Zoom conferencing and hosted within the Board Room of the Kellogg Community College Roll Administration Building, 450 North Avenue, Battle Creek, MI.

Chairman Claywell called the meeting to order at 6:30 p.m. Roll and each trustee's physical location if attending remotely was taken, reflecting the following:

Twenty-six individuals, comprised by Trustee Student Representative Payton Espolon, KCC executive leadership, President's Council members, college staff and community guests, participated via Zoom. Zero individuals participated via conference call.

ADJUSTMENTS TO THE AGENDA

President Dr. Bennings requested an adjustment to the agenda, adding a recognition of KCC Baseball Coach Eric Laskovy as the first agenda item and removing Action Item "F" relating to the Custodial Services recommendation from the agenda. With a motion by Trustee Byrd and supported by Trustee Booth, the Board unanimously approved these adjustments.

CONSIDERATION OF MINUTES

Minutes from the regular meeting held on April 21, 2021, were approved as written by the Board unanimously, with a motion by Trustee Booth and supported by Trustee Byrd.

PRESIDENT'S REPORT

Recognition of Coach Eric Laskovy: Coach Laskovy was recognized for 500 wins as coach of the KCC baseball team. He also acknowledged his assistant coach, Jim Miller, and mentor, the late Russ Bortell.

MCCA All-Michigan Academic Team: Dean of Student Services, Terah Zaremba, praised Sarah Smith and Payton Espolon, two students who were named to the MCCA All-Michigan Academic Team based on academic achievement, community service involvement, and leadership accomplishment.

Restructuring and Organizational Change Update: Vice Presidents Eric Greene (Strategy, Relations, and Communications) and Dr. Paul Watson (Instruction), Chief Financial Officer, Rick Scott, Director of Finance, Tracy Beatty, and Chief Information Officer, Greg Colegrove, provided insight on the organizational changes transition affecting their divisions and departments over the past several months.

Campus Reopening: In response to the pandemic, the College is hosting drive-through vaccination clinics every 3 weeks for the Calhoun County Health Department. The College is awaiting updates from MIOSHA regarding the recent changes to mask requirements.

Infrastructure, Planning, and Sustainability (IPS) Council Update: IPS Council co-chair, Brad Fuller, provided a progress report on campus improvements, and the College's architect, Tom Mathison from Mathison, detailed the planned renovation to the Schwarz Science building.

Scholarships and Grants: The College received no scholarships or grants in April.

MCCA Updates: The MCCA Board of Directors met recently and Dr. Bennings shared some highlights from the meeting, touching on topics such as the American Families Plan's possible funding increases and focus on student success initiatives. Additionally, she volunteered to serve on a committee of 6 presidents and 6

trustees to review the process by which board members are elected to important leadership positions within the association.

KCC Foundation: On behalf of Executive Director, Teresa Durham, Eric Greene presented the Foundation's updates for this month. Highlights included the Bruin Open, to be held September 10, raising \$42,000 to-date, the Foundation's portfolio achieving another all-time high at \$13.6 million, and the awarding of 456 scholarships worth \$470,700 for the 2021-22 year.

Strategic Plan Update: Dr. Bennings provided a summary of recent work at the College to propose projects and initiatives as part of the current strategic plan. A series of proposals are currently under review by trustees and employees in order to determine the goals and objectives to be presented for Board approval at a future meeting.

At her last Board meeting as Trustee Student Representative, Payton Espolon offered a student's perspective of the final part of the semester, including midterms and graduation.
