# **CONSIDERATION OF MINUTES**

Minutes of the August 20, 2014, regular meeting were approved as written in a motion by Trustee Byrd and supported by Trustee Davis.

#### PRESIDENT'S REPORT

**Employee of the Semester:** Dr. Bona introduced the Fall 2014 recipients of the G. Edward Haring Employee of the Semester Award: Mr. Simon Thalmann, Digital Marketer/Writer, Public Information and Marketing; Ms. Cindy Lingbeek, Staff Assistant, Support Services; and Ms. Kim Madsen, Faculty, OIT. Mr. Gregg Hall, Maintenance, Utility II, also received the award but was unable to attend the meeting.

**KCC** Advanced Manufacturing Assembly (KAMA): Ms. Sara Hubbard, Director of Workforce Solutions, provided a presentation to the Board regarding the new KAMA program. The certification based program prepares students for high wage, high demand careers by providing a hands-on, structured learning environment that replicates what they would experience on the job at a state-of-the-art manufacturing facility. The program has gained recognition on the State level along with the local employers and non-profit community.

**Campus Crime Statistics:** KCC continues to experience an exceptionally low incidence of crime on campus with zero reportable crimes for 2013. However, two incidences of stalking were reported from the previous calendar year in the annual security report to students and staff. This was part of a request from the Department of Education to make a "good faith" effort to comply with preliminary guidance for the Violence Against Women Act (VAWA) of 2013.

**Enrollment Update:** Enrollment has improved slightly. Current numbers show a 4% decrease in contact hours and a 5% decrease in credit hours. However, KCC continues to lead the State with an 8% increase in headcount.

**State Legislative Update:** The Michigan New Jobs Training Program (MNJTP) has been impacted dramatically by the increase in minimum wage since companies participating in the program are required to pay 175% of minimum wage to be eligible. The Michigan Community College Association (MCCA) is working to help find solutions for the issue. At the very least, it is expected that companies currently participating in the program will be grandfathered into the wage structure.

The possibility of community colleges offering a baccalaureate in nursing is moving forward with the support of MCCA and some of the community colleges themselves.

Legislation is also being considered that would allow for non-continuous district annexation.

**Impact of Right to Work:** Ms. Ali Robertson, Director of Human Resources, updated the Board regarding the impact of the Right to Work law that went into effect at KCC in July of 2014 with the renewal of the bargaining unit contracts. Currently there is a window allowing union members to "opt out" of the unit but it is being challenged as an unfair labor practice. KCC is respecting the window until notified otherwise. So far the Right to Work has had minimal impact at KCC.

**Capital Outlay Plan:** To participate in the Capital Outlay Process, the Five-Year Capital Outlay Plan is required to be on file with the State of Michigan. The document provides state policymakers with the most current information available on institutional priorities as they relate to college facilities and capital improvement needs. KCC's plan has been rewritten and will require Board approval in October. The Miller Physical Education, Wellness and Community Services Building is listed as KCC's priority project for State funding. Dr. Bona will present the plan to the capital outlay subcommittee in Lansing on September 24.

**Renovation and Capital Improvements Update:** Mr. Mark O'Connell provided a brief update on the progress of the Binda Theatre and Davidson Center projects. Binda is on schedule and projected to come in under budget. Bids for Davidson are due back at end of September and a recommendation is expected for the October board meeting.

**Kellogg Community College Foundation Update:** Ms. Teresa Durham reported on a very successful Bruin Open which raised over \$93,000 for scholarships. The annual KCC Foundation scholarship dinner will be held at the Battle Creek Country Club on October 9. Adopted for Connect Day during Community College Week, the slogan "Always a Bruin" will continue to be used by the Foundation in the ongoing effort to connect with alumni.

**Community College Week:** Designated by the MCCA, the first-ever Community College Week provided an opportunity for students, employees, and the public to participate in events reflecting the College's mission. Mr. Eric Greene, Director of Public Information and Marketing, shared with the Board information on activities that included ways to Connect, Engage, Remember, Move, and Serve. Mayor David Walters, City of Battle Creek, also proclaimed September 15 – 19, 2014, as Community College Week.

**Bruin Blast/Constitution Day:** Ms. Terah Zaremba, Dean of Student Services, was pleased to report that almost eleven hundred individuals took part in the annual Bruin Blast and Constitution Day held on September 17. The day included fun activities to engage the students with campus departments and community and student organizations. District Judge John Hallacy, joined by KCC honor students, provided an opportunity to learn about and understand the constitution with a constitution quiz show.

**Scholarships and Grants:** This month the college received \$103,680.00 in scholarships. This brings the total for the year to \$203,844.75. These contributions are accepted with appreciation and great gratitude on behalf of the students and the College.
