Kellogg Community College Minutes of the Regular Meeting of the Board of Trustees May 18, 2022

The Kellogg Community College Board of Trustees met in a regular public session on May 18, 2022, at 6:30 p.m. in the Board Room of the Kellogg Community College Roll Administration Building, 450 North Avenue, Battle Creek, MI. A Zoom conferencing option was available to staff and the public.

Chairman Claywell called the meeting to order at 6:36 p.m. Roll call was conducted.

ADJUSTMENTS TO THE AGENDA: There were no adjustments to the agenda.

CONSIDERATION OF MINUTES: The Board of Trustee unanimously approve the minutes from the regular meeting held on April 20, 2022, with a motion from Trustee Davis and supported by Trustee Byrd.

PRESIDENT'S REPORT

Ransomware Incident Update: Dr. Watson shared an update pertaining to the ransomware incident highlighting the college was able to resume operations safely and securely on May 4. The investigation is in the early stages and Dr. Watson will update the Board as more information becomes available.

Recognition of KCC Volunteers and Board of Trustees' Support:

Dr. Watson shared that fifty-seven employees, from all classification groups, volunteered their time and effort to help the twelve IRT members during the incident. Dr. Watson recognized Chairman Claywell for delivering supplies for the IRT team and Tia Burrill, student, who helped with her positivity on social media. Chairman Claywell, on behalf of the Board, extended gratitude for the professionalism of the college and how staff pulled together to help during the incident.

KCC Leads: Dr. Watson shared that Mr. Kevin Barnes has been named as a member of the Board of Directors for Tillers International and Dr. David Tannor was elected the president of MichMATYC.

Enrollment/Registration Activity Update: Dr. Watson shared an update of registration and enrollment information for the summer semester as of May 9.

Infrastructure, Planning, and Sustainability Council (IPS) Update: Mr. Brad Fuller provided an update about the reflecting pool repairs; seeking approval for parking lot resurfacing; exploring options for roof replacement for the Fehsenfeld and Grahl Centers, creating cost estimates for building repairs for the Grahl Center, and finding an alternative location for the MSU agriculture program trailer.

KCC Foundation Update: Ms. Teresa Durham reported the KCC Foundation's recent activities. Ms. Durham recognized the Starfish and KCC Alumni Award winners.

Scholarships and Grants: The April monthly receipt in external gifts and grants to students was \$1,855, bringing the 21/22 fiscal year total to \$269,400.96.
