
## 2024-2025 Magnetic Resonance Imaging (MRI) Admission Packet Summer 2024 Program

Deadline — February 1, 2024 Application available November 1, 2023 Program begins Summer 2024



The MRI program at Kellogg Community College prepares students to enter the career of medical imaging as a magnetic resonance imaging technologist. The program includes a rigorous curriculum of classroom, lab, and clinical education experiences in the Medical Imaging departments of hospitals and other health care facilities preparing the student for success on the national certification exam administered by the American Registry of Radiologic Technologist (ARRT) (https://www.arrt.org/about/about-us).

This is a competitive point-based admission process. Points are awarded for grades in coursework, degrees earned and calculated GPA from **all** accredited colleges/universities attended.

All students **must** complete a KCC General Application and have met **all** admissions requirements prior to applying to the MRI program.

## 2024/2025 ALLIED HEALTH POINT SHEET: MRI

Admission to the Magnetic Resonance Imaging program is determined through a competitive points and ranking system. Applicants are evaluated, awarded points and ranked based on various criteria related to their academic achievement.

# To be eligible for the MRI program, students must submit a completed MRI application. After the deadline closes, eligible students will be assigned an additional writing task. This assignment carries significant weight, accounting for 50% of the overall ranking.

#### **IMPORTANT NOTES:**

- Future employers may require a proof of high school or GED completion as an employment requirement.
- Meet early and often with an Academic Advisor after completing KCC's General Application and submitting college transcripts but prior to submitting the MRI application, to review course specific requirements and transfer equivalencies.
- Transfer transcripts should be on file and evaluated by KCC's Registrar's office before meeting with an Academic Advisor to get the most out of your appointment. Please note that it can take a maximum of two weeks for in-state transcripts and four weeks for out-of-state transcripts to be evaluated.
- Students accepted into the MRI program are required to undergo a physical examination, immunizations, a drug screen, and a criminal background check. Individuals may obtain a preliminary determination from the state of Michigan Department of Licensing and Regulatory Affairs (LARA) concerning whether any court judgments against him or her would likely result in a denial of a license.
