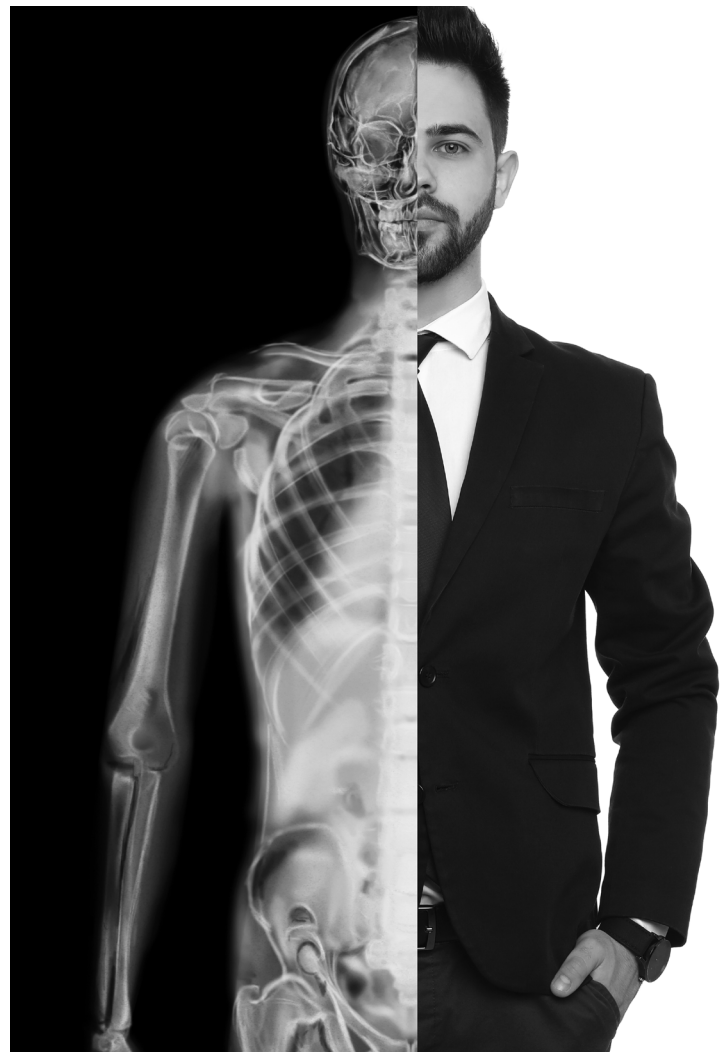


2024-2025 Radiography (RADI) Admission Packet for Fall 2024 Program

Kellogg Community College's Radiography Program consists of classroom lecture and supervised clinical experience. The program's extensive clinical experiences require the time commitment of a full-time student. Successful completion of the program leads to eligibility to take the national certification examination of American Registry of Radiologic Technologists.

This is a competitive point-based admission process. Points are awarded for grades in coursework and degrees earned.

All students **must** complete a KCC General Application and have met **all** admissions requirements prior to applying to the RADI program.

REQUIRED RADI COURSEWORK PREREQUISITES

The following courses must be completed prior to admission to the Radiography program.

All courses must be completed with a grade of a C (2.0) or better.

- ☐ *ALHE 227 2 credits Medical Terminology
- ☐ *BIOL 201 4 credits Human Anatomy
- ☐ *BIOL 202 4 credits Human Physiology
- ☐ ^MATH 102 4 credits Practical Algebra (or higher level math course)
- ☐ † NURS 105 3 credits Nursing Assistant Training
(or current State Certification as a Nursing Assistant)

* Denotes competitive application points for the RADI program.

^ The MATH requirement may also be met by scoring 250 or higher on ACCUPLACER Quantitative Reasoning; 25 or higher on PSAT/SAT Mathematics; or 46 or higher on ALEKS Mathematics. Math placement test score must be completed within six years from the start of program.

† NURS 105 must be successfully completed at KCC within two years prior to the program application deadline date, or a current State of Michigan Nursing Assistant Certification will be accepted in lieu of the NURS 105 course.

NOTE: BIOL 201 and BIOL 202 must be completed within 6 years of the start of the Radiography program.

IMPORTANT NOTES:

- Future employers may require a proof of high school or GED completion as an employment requirement.
- Meet early and often with an Academic Advisor after completing KCC's General Application and submitting college transcripts but prior to submitting the RADI application, to review course specific requirements and transfer equivalencies.
- Transfer transcripts should be on file and evaluated by KCC's Registrar's office before meeting with an Academic Advisor to get the most out of your appointment. Please note that it can take a maximum of two weeks for in-state transcripts and four weeks for out-of-state transcripts to be evaluated.
- Students accepted into the RADI program are required to undergo a physical examination, immunizations, a drug screen, and a criminal background check. Individuals may obtain a preliminary determination from the state of Michigan Department of Licensing and Regulatory Affairs (LARA) concerning whether any court judgments against him or her would likely result in a denial of a license.
